### Get ready for book setup questions in the next release of VI Assets

Our next release of VI Assets, version 1373, is almost ready. This version will require a full install of the software as some major enhancements have been added. This next release will also ask you three questions (per company and per book) during the database update, relating to your financial year start period and year. This information is used mainly for those using Australian tax rules where the calendar month is important as well as better reporting. You can view these questions now by opening the attached pdf document.

#### Prerequisites

- Workstation is operating on Vista or later (Windows 7 or 8)
- .Net Framework 4.0 (full version) is installed

#### FAQ's

Q: Is this version compatible with a 64 bit machine?

A: Yes, this version is compatible with 64 bit machines.

Q: Can this version be installed on our terminal server or Citrix environment?

A: Yes, this version can be installed on a terminal server or Citrix environment.

Q: Does this version integrate with AccountRight Live?

A: This version can integrate with both the desktop and cloud version of AccountRight Live; versions 2013.3, 2013.4 and 2013.5. It still works with AccountRight version 19.5 as it is backwards compatible.

Once we have finalised the testing of the new version. we will email you with a link to download the latest files to upgrade your version.

## Selling on Trademe?

Are you an Exo Business user selling stock items on Trademe? If you find the task of listing and maintaining auctions tiresome, and long for a more efficient way of updating stock levels in Exo, as well as creating sales orders, invoices and payments when items are sold, then you can empathise with clients using eBay! We looked into the problem and the Exo2eBay application was created.

So, what is Exo2eBay? It's an interface that mirrors the eBay listing options so you only have to fill out the listing information once. After you have marked the stock items you wish to sell on eBay, they will appear in our Exo2eBay interface for you to quickly set up its listing details such as Title, Description, Price, Returns policy, Postage method, Handling time. You can add pictures, diagrams and tables as well.

Monitor auction sales, buy now orders and unsold auctions. It creates Sales Orders in Exo when items are sold, if payment is made, the invoice and payment is also created and matched. That leaves you with the despatch from Exo.

- ❖ *This tool enables you to quickly list items using information already stored within Exo then create the accounting transactions without re-keying as they occur. Once setup the item can be relisted with a single click.*
- ❖ *Sales Orders (and debtors if required) will be created in the Exo system ready for dispatch and invoicing using your standard Exo features or when a PayPal payment is received.*
- ❖ *Keeps the history of items listed and how many were sold allowing you to plan future auctions.*
- ❖ *No reconciliation required as data is automatically transferred.*
